Covid-19 Emergency Funding

Allchurches Trust: Hope Beyond.

Allchurches Trust Hope Beyond grants programme aims to enable churches and Christian charities to apply for up to £50,000 to meet changing needs within their communities, helping them and the communities they support to adapt to the challenges and opportunities presented by the Coronavirus pandemic.

Through our Hope Beyond grants, we aim to fund innovative, impactful projects that will enable people, organisations and communities to flourish in life after lockdown, building resilience and encouraging hope within these 3 key areas:

- Projects responding to the issues of loneliness and isolation exacerbated by the Coronavirus pandemic where new and/or enhanced support is being proposed. This could include enabling improved accessibility to buildings/activities and measures to ensure buildings are Covid-19 safe
- Projects focused on growing community resilience and promoting mental and emotional health and wellbeing, including the provision of mental health and wellbeing support groups and 1:1 counselling for people of all ages (including clergy).
- Projects focused on growing technological capability and resilience, particularly increasing digital capacity and provision, and supporting those without online access to get online through training and support.

- o Redecorating properties.

Burg-Wächter Secure Communities Scheme

Burg-Wächter Secure Communities Scheme offers free security kits, up to a value of £150, for community properties, equipment or outdoor areas that need extra security at this time and have limited funds to meet these needs. The scheme prioritises grassroots organisations who have the most difficulty in meeting extra security costs due to the current situation. Any property, equipment or area that is the responsibility of the local community is relevant, including allotments, sports clubs, village halls, common land or community centres. That means any charity, social enterprise, not for profit and community venture can apply so long as the security kits will be used locally.

The Care Home Friends and Neighbours Intergenerational Linking Project.

Grants of up to £31,000 for registered charities, not-for-profit organisations and local authorities in England for projects that link younger people aged 5 to 14 from schools and youth organisations with older people living in local care homes.

Grants are available for intergenerational linking projects that bring together older people who live in care homes with young people aged 5 to 14 years in schools or youth groups, with an emphasis on reaching young people who are located in less socio economically advantaged areas.

Funding is for 18 months, with a start date of 1 April 2021. This will include a period of approximately 6 months for planning and 12 months for project delivery.

The aims of the programme are to:

- Create a world where care homes are truly connected to their communities.
- Improve young people's confidence and develop their leadership skills.
- Sustainably embed intergenerational linking into the curriculum and ethos of a school and/or youth organisation.
- Eligible projects should aim to enable young and older people to:
- Build meaningful intergenerational friendships which increase a sense of connection and reduce feelings of isolation, especially during lockdown.
- Imagine and design a range of different activities together, encouraging creativity, giving ownership and increasing feelings of connection and fun.
- Learn from one another and share in new experiences together, broadening understanding of who the all are and how they all live together.

Projects must be run within two distinct neighbourhoods within an area. Grants can be used to cover a range of costs, including staff costs and overheads.

Comic Relief COVID-19 Community Fund:

Grants up to £4,000 local, grassroots organisations in England to provide emergency relief and recovery from the coronavirus (COVID-19) pandemic.

The fund aims to enable local grassroots organisations in England to respond to the needs of vulnerable individuals, families and communities during COVID-19 and help them recover from the impact the pandemic crisis has had on their services. Applying organisations must have an annual income of less than £250,000 and include people with lived experience of the services being provided (for example, a homelessness service should involve people who have experienced homelessness in the running of the organisation and who are helping shape how services should be provided). Organisations supporting Black, Asian and Minority Ethnic (BAME) and Lesbian, Gay, Transgender, Queer (or Questioning) + (LGBTQ) communities will be prioritised.

Deadline: Thursday 31 December 2020. The programme may close earlier if all the available budget has been committed. Early application is therefore advised.

Cornwall Community Foundation (CCF) Emergency Fund:

If your community group or charity operates in Cornwall or the Isles of Scilly and you are helping people impacted by the Coronavirus crisis, CCF Emergency Fund has grants immediately available to support your vital work. Each application will be considered on an individual basis, with grant awards ranging from £1,000 to £10,000 (or larger in exceptional circumstances).

Funding is available to meet two strands of community need:

- <u>1. Emergency and crisis</u>: for community groups helping people survive during the crisis by supporting their immediate, emergency needs.
- <u>2. Build Back Better:</u> for community groups looking beyond immediate crisis provision to develop or reopen services for the future.

The Fund is open to the following organisations:

- registered charities, including charitable incorporated organisation
- constituted organisations and non-registered charities

- special arrangement apply for community interest companies and community benefit societies.
- churches and other religious organisations (for community support activities only)
- partnerships or organisations working collaboratively. The lead applicant would need to be one of the above special arrangements apply for large organisations

Cornwall Council Community Chest Crisis Scheme

This scheme is primarily intended to help the small, un-constituted groups who are supporting local communities through the coronavirus crisis. It is also intended to help groups whose funding is impacted by the coronavirus crisis.

Cornwall Council Community Chest Crisis Scheme gives grants of up to £1,000 to smaller un-constituted groups who are supporting local communities through the coronavirus crisis.

The programme operates across all of Cornwall's 19 Community Network areas, and groups can apply for grants from individual Cornwall councillors.

To apply, simply email your Community Link Officer (CLO) with brief details of your group and the work you're doing In the email also copy in communitynetworks@cornwall.gov.uk. The CLO will then contact the relevant Cornwall Councillors to see if they are willing to support your project in principle. Details of the 19 CLOs are on the Community Network Map that can be accessed through the above weblink.

Coastline Housing is match funding the scheme in the three, main community network areas in which it operates:

- 1. Camborne, Pool, Illogan and Redruth;
- 2. Helston and South Kerrier;
- 3. and parts of Falmouth and Penryn.

This means that community groups in those areas bidding successfully for Community Chest funding would see their cash injection go up by half through Coastline Housings contribution.

LGBT+ Futures: National Emergencies Trust Fund

Consortium, a nationalist specialist infrastructure organisation that works to strengthen and support the Lesbian, Gay, Bisexual and Trans+ (LGBT+) community, has launched a new grant programme offering grants up to £15,000. LGBT+ groups across the UK impacted by the COVID-19 pandemic may apply.

Grants will be awarded on a "First come, first served" basis until the £350,000 budget has been fully allocated, so early application is strongly advised for this programme.

The Linnean Society – UK Nature Engagement Grants

Grants of up to £1000 are available for schools and community groups in the UK to increase youth engagement with nature.

These grants are available to fund innovative projects, designed and led by young people, which aim to increase access to local natural spaces and encourage a deeper appreciation and understanding of nature. Our application process is designed to be simple to allow young people to apply with adult support from their schools or community groups To be eligible for a grant, you must be able to show your link to a UK primary or secondary school or a UK community-based organisation that works directly with young people (16 and under). The project should be designed by young people and led by them, and should seek to affect change or empower local young people and the surrounding communities to increase access to natural spaces and improve understanding of local biodiversity. As long as your proposal meets the above criteria, this is entirely up to you. We recognise the expertise of young people, supporting adults and community leaders, so we are keen to hear what activities you think would work best for engaging people with your local nature and natural spaces. The grant can be used for materials, room hire, publicity, speakers, trainers, freelancers, project-specific staff costs, audio-visual hire, reasonable volunteer expenses, transport or other costs of activities/ events. However, the grant cannot be spent on large prizes, large non-consumable equipment (e.g. purchasing microscopes or computers), on-going salary costs, costs that are

already covered by other funding, general running costs and overheads that are paid for by other income. More than half of the grant cannot be spent on refreshments or project specific staff costs.

Local Giving Magic Little Grants 2020 programme.

Together with Postcode Community Trust, a grant giving charity funded by players of People's Postcode Lottery, Localgiving is delighted to offer charitable organisations the opportunity to apply for grants of £500.

The fund will be awarding over 900 grants to community projects across Great Britain. The aim of the fund is to engage with organisations that are supporting hard to reach individuals, encouraging them to take part in some form of physical activity to help improve their physical and mental health and wellbeing

Applications will receive a decision on their application and, if successful, the funding within two months of submitting a complete application. Deadline for applications 31st October 2020.

More than a Pub: The Community Pub Business Support Programme

Want to take ownership of your local pub and run it for the benefit of the community? Need help getting it into community hands?

The More than a Pub programme provides business development support to enable the community control of pubs in both rural and urban communities across England.

During the covid-19 lockdown they offer combined finance packages of up to £100,000 are available (£50,000 loan and £50,000 grant) to help community groups secure control of their local pub. The loan is not optional and, as well as completing the MTAP paperwork, we will ask you to apply to either Co-operative and Community Finance or Key Fund (please wait for confirmation from us as to who you should apply to). Please note, there are a very limited number of loan and grant packages available, so this will be a highly competitive process. Email info@plunkett.co.uk to request an application form.

Music for All, Community Project Grants.

Grants up to £2,500 for UK community groups to bring musical projects to local communities.

Music for All Community Grants are normally given for the purchase of instruments, associated equipment or for teaching costs. However, all applications are judged on their merit and other project elements may also be considered.

The main aspects that the trustees look for in an application are:

- o The number of new musicians the project will create and support.
- o The sustainability of the project (to ensure that people are able to continue their musical journeys), and o Whether there are any other organisations supporting the project that can help with funding, or if funding applications have been made to other charities. (Music for All likes to help as many applicants as it can, so often works with other organisations to enable projects to gain the full support required.)

National Lottery Community Fund: Emergency Funding (up to £10k)

This category includes:

- organisations supporting older people;
- disabled people (including people with long-term health conditions);

- Black, Asian and Minority Ethnic (BAME) communities; all of whom are facing specific challenges during the current crisis.

Currently Employed: At least 1 years' service

Grants may support:

- A sudden or unexpected loss of income
- A sudden or unexpected illness or injury
- A sudden or unexpected change in living circumstances or loss of home
- A relationship breakdown
- An issue of domestic abuse
- Death of a close relative

The Care Workers' Charity COVID-19 Grant Fund aims to provide emergency funding for individuals who are currently employed in a role that is involved in or supports the provision of adult, elderly or disability care. These may include residential social care, domiciliary/home care, supported living care.

The Care Workers Charity is currently offering the following grants:

- ISOLATION AND SHIELDING GRANTS If you have taken one, two or more weeks off work due to Covid-19 for either illness, self-isolation, or shielding. We are currently awarding between £250 (1 week of self-isolation), £500 (2 weeks of self-isolation), up to £2,000 (12 weeks of shielding).
- FUNERAL COST GRANT If you are a care worker who is responsible for paying the funeral costs of a next of kin (partner, parent, sibling, child, or other on a case-by-case basis) OR if you are the next of kin for a care worker who has passed on from COVID--19, then we are awarding grants of up to £2000 Bottom of Form

If you are currently signed off sick, shielding or self-isolating (for 2 weeks or more) due to Covid-19, please apply for the Covid-19 Emergency Fund Grant.

NEW! You can now apply for Child Care costs for up to £2000.

- You have been injured at work or outside work and expected to be unable to work for more than 6 months
- You are suffering an illness that prevents you from working for a period longer than 6 months
- You are now the full time primary carer for a spouse or child
- You are suffering a long term, life changing or terminal illness

If you meet the above criteria, apply now below or call our helpline 0345 605 1956.

The applicant will need to comply with the following criteria:

- Be currently working or a former worker in the construction industry or allied trades or
- An apprentice to a construction trade
- *Applications can be submitted on behalf of somebody fulfilling this criteria as long as they have the applicants permission.

The Shaken Not Broken Fund is a grant scheme created by Campari UK in partnership with TipJar and The Drinks Trust. Its aim is to provide much-needed support to front-line workers in the hospitality industry during and after the COVID-19 pandemic.

Grants are awarded up to £500. Applications for individuals will be processed within 5 working days and we will aim to inform the sponsor agency within 10 working days of the outcome.

Our grants can help parents and carers who have worked in the UK fashion or textile industry and whose household income has reduced as a result of the coronavirus outbreak.

If you're struggling to make ends meet, our grants can fund items for your children such as clothing, bedding and essential household items.

To apply for an FTCT grant, one parent/carer must have worked in the UK fashion and textile industry, for at least one year within the last nine years. It doesn't matter where you've worked in a fashion or textile business, from store, to head office and distribution.

Our grants typically help families who are already struggling financially (in arrears on your household bills or have debt) OR have limited savings to cover lost earnings.

You might want to apply if you or your partner's income has been affected in any of the following ways:

- Made redundant or were already redundant and now can't get a new job
- Have been furloughed (temporarily laid-off) and can't afford to fund the 20% or more reduction in income
- Have been put on reduced working hours
- Have been made to take unpaid leave to care for your children
- Have lost self-employed income and are not eligible to apply for the new Self-Employed Income Support Scheme (SEISS) and can't fund your lost income. OR can't fund your lost income until the SEISS scheme pays out
- Have to self-isolate and are not entitled to furlough/sick pay or your employer can't/won't pay it

There are many other ways families are being affected at this time, so if you are experiencing hardship in other ways, please read on.

What we fund

We encourage parents and carers to apply for items your children will need for the year ahead.

These might be items you were planning to buy, but now can't due to lost wages, including:

- Essential clothing, e.g. seasonal clothing and school uniform and PE kit.
- · Baby clothing, equipment or bedding
- Children's bedroom furniture, e.g. beds, bedding, clothes storage furniture (chest of drawers)
- Essential White Goods, e.g. replacing a broken appliance such as fridge/freezer, washing machine, cooker/oven.
- Specialist items for children with additional needs, e.g. sensory toys, adaptive clothing or SEN adapted computers

If you work or have worked in the UK furnishing industry, you may qualify to receive financial support and guidance to help you through a difficult time. To be eligible for financial assistance, you must normally have a minimum of two years' employment service in any capacity within the UK furnishing industry. However, During the COVID-19 crisis, we are accepting applications from people with shorter service periods. *This includes companies manufacturing/supplying furniture, kitchens or bathrooms; furniture stores such as DFS, Ikea, Argos; carpet sales or fitting; beds, curtains and upholstery.

As a guide, we often help with essential household bills, such as rent/mortgage, council tax, gas and electricity. Or with replacement items such as cooker, fridge or washing machine.

Small and Major Grants for UK charitable organisations, registered charities, voluntary organisations, Community Interest Companies (CICs), social enterprises and not-for-profit registered companies organisations to fund arts, community support, education and heritage projects in areas of extreme urban deprivation or remote, socio-economically deprived rural areas.

The Small Grants programme reopened on Monday 12 October and The Major Grants programme is scheduled to reopen on Monday 9 November 2020. Both are rolling programmes with no application deadline.

Grants are available for general costs, including core costs, salaries, projects costs, and capital expenditure on buildings or essential equipment. Applications for revenue or capital grants must demonstrate how the project fits into one or both of the Foundation's overarching themes of rural issues and urban deprivation in the following two fields:

- 1. Arts, Heritage and Education (for example, Community Arts Hubs, supplementary educational classes, homeworking or homework clubs, engaging more people in the arts), and/or
- 2. Community support projects (i.e. lunch clubs, support for young carers, community centres, foodbanks).

 Rural Issues projects should address issues in rural towns/villages/communities with fewer than 10,000 inhabitants with postcodes that are ranked within the most deprived 50% of the latest government Indices of Multiple Deprivation. Communities should be in remote, rural, economically deprived areas where there are few local facilities, transport may be an issue, incomes are low and there are limited opportunities for fundraising.

Urban Deprivation projects should address issues in cities/towns with a population of more than 10,000 with postcodes that are ranked within the most deprived 15% of the latest government Indices of Multiple Deprivation. Local issues are likely to include multigenerational unemployment, poor educational attainment, poor quality and overcrowded housing, tensions between different generations and/or ethnic communities, and a culture of low aspirations and achievement.
