- 1. Community: new build, refurbishment and improvements of village halls, scout huts, youth clubs, community centres and similar. This often includes access for the disabled, modernising kitchens, new storage space and updating toilets in line with Health and Safety regulations and the Disability Discrimination Act.
- o Village Hall grants, particularly in isolated rural areas where there are limited community facilities. - 4. Social Welfare grants can range from support for residential premises such as centres for young people at risk, drop-in centres for people who are homeless, and day centres for the elderly. The Social Welfare priority also provides grants for the welfare of ex-military service personnel and those who have worked in the emergency services, especially for projects that address mental health issues. Educational and training facilities may also be supported under this category.

Registered charities and exempt charities in England and Wales may apply for a grant. Applications from eligible organisations working in remote rural and isolated areas are welcomed.
