## Covid-19 & Emergency Funding

### The Alpkit Foundation

The Alpkit Foundation are now prioritising their funds to support projects that demonstrate an immediate impact on those affected by the Covid-19 virus crisis. Over £200,000 has been awarded to more than 600 incredible projects so far, with a number of community food schemes supported. This grant is simple to apply for.

Examples include:

- Being active in your local community to help elderly or vulnerable people.
- Minimising the impact of self-isolation for those in quarantine and need access to food, medicines or social care.
- Supporting foodbanks and increasing the number of meals on wheels deliveries to support the elderly.
- Supporting those who are homeless or in temporary accommodation.
- Bringing adventure indoors.
- Projects that encourage responsible and Covid-19 safe outdoor activity.

### The Art Fund Reimagine Programme

Small and large capital and revenue grants between £5,000 and £50,000 are available to a wide range of UK charitable organisations, including Community Interest Companies (CICs), galleries, libraries and museums for activities that build expertise, capacity and connections within and beyond the UK arts sector.

Funding is available for arts projects across the UK that:

- o Enable experimentation rooted in the current context for organisations.
- o Include meaningful engagement with diverse audiences, and/or
- o Result in greater expertise within the arts sector.

In particular, the Reimagine Programme aims to:

- o Help organisations build expertise, capacity and connections within and outside the arts sector, and
- o Support arts organisations as they reimagine their activities following the COVID-19 pandemic.

Please note that projects should be concluded within 24 months of funding being approved.

\*The last application deadline was 23<sup>rd</sup> August but they do have a further deadline scheduled for 2021 (not currently available to see on their website).

### ASDA Foundation Bringing Communities Back Together grants (phase 2)

The ASDA Foundation's Bringing Communities Back Together Grants programme is designed to support a celebratory event or to enable activities and services to recover after the disruption of COVID-19. Offering grants of between £250 and £1,000, all events MUST take place between 1st October 2021 and 31st December 2021.

Open to UK registered charities, not-for-profit companies, Community Interest Companies (CICs), unincorporated clubs or associations, Parent Teacher Associations (PTAs), and school support groups supporting extra-curricular activities may also apply.

o A Celebration Event – for example, a welcome back party or a community celebration. Eligible costs include meals for the event, decorations and entertainment. Proposals can include up to £50 for decorations; a maximum of £12.50 for a meal per person and entertainment up to £125 per application.

o Getting Activities Back on Track – for example, supporting recreational activities, or  
o A combination of the above - for those wanting to apply for both celebration event and getting activities back on track.

Applicants should:

- o Be local to an ASDA store (a store location finder is available at this [LINK](#)).
- o Have a presence in the local community and/or work to benefit that geographical area.
- o Have the aim of bringing people back together as social distancing guidelines have eased.
- o Ensure that everyone has an equal opportunity to be involved.

\*Application deadline: It is suggested that groups submit applications to the Community Champion prior to 1st November to allow the store time to process and submit to the Asda Foundation prior to the deadline on 5<sup>th</sup> November.

### Burg-Wächter Secure Communities Scheme

Burg-Wächter Secure Communities Scheme offers free security kits, up to a value of £150, for properties, equipment, or outdoor areas that are used in service of the community and need extra security at this time. The scheme prioritises grassroots organisations who have limited funds and the most difficulty in meeting extra security costs due to the current situation. Any property, equipment or area that is the responsibility of the local community is relevant, including allotments, sports clubs, village halls, common land or community centres. That means any charity, social enterprise, not for profit, or community venture can apply so long as the security kits will be used locally.

### Paul Hamlyn Foundation - Covid 19 Support

Paul Hamlyn Foundation have reopened applications to their Covid-19 support fund as of the 30th of October 2020. They have a £20 million emergency fund, and have already made over 350 grants totalling £11 million. They are still prioritising organisations that they have an existing funding relationship with and state that *'Awards through the Emergency Fund are continuing. **This is not an open application fund and you will need a PHF grants manager to support your case. See the PHF website for more details***

### Sport England: Active Together

Up to £10,000 in match funding, as part of a support package to help clubs and organisations set up and run crowdfunding campaigns related to Covid-19.

Sports England are helping sports clubs and other organisations to set up and run their own crowdfunding campaigns to help sustain themselves through the coronavirus (Covid-19) crisis.

This funding option is about supporting local clubs and organisations through the coronavirus crisis and with the return to play.

This may be the implementation of changes needed to ensure you're adhering to the latest government guidelines around social distancing, it may be the need for additional coaching, facility hire or the purchasing of personal protective equipment to make sure everyone who takes part in activity at your venue is safe.

It could be that a loss of income has severely impacted your ability to survive, or the need to undertake essential maintenance of your facilities that are now not possible due to the crisis.

### **Sport England Return to Play: Small Grants**

Awards of between £300- £10,000 that support clubs and community groups respond to the challenges of returning to play in a coronavirus-safe way.

This could include contributing to covering the costs incurred by having to deliver activity in smaller groups than normal, or having the correct hygiene and safety equipment.

Funding could be used for minor amendments to facilities, additional sports equipment, signage, sanitation and training courses to help you deliver your activities safely. Applications should be focused on returning people to previously run activity, or enabling previous projects to adapt to resume delivery, when that's possible. At this time the fund is not looking to support new projects or start-ups.

Applications should be focused on the key funding priorities of:

- Projects located in areas of high deprivation (decile 1-3 of the Indices of Deprivation).
- Organisations working with Black, Asian and minority ethnic communities, people on lower incomes, disabled people, people with long-term health conditions and people experiencing a greater burden of care because of coronavirus.
- Organisations that don't have a significant level of reserve funding available to utilise.

### **The Sylvia Waddilove Foundation UK**

The Foundation has set up an emergency fund to help small to medium sized organisations who are struggling to manage the financial impact of COVID-19 either because of increased demand for their services or loss of income. The fund is targeted at organisations in a critical position. Grants are for a maximum of £1,000.

Who can apply:

- The organisation must be a charity, CIC or registered society
- The organisation's income must be no more than £500,000 and have free reserves of no more than £100,000
- The organisation must operate in one of the following categories:

Education relating to non-domestic animals (this includes animal husbandry, veterinary science, animal welfare and surgery, and organic farming). Applications concerning domestic animals like dogs and cats are not accepted

Visual and performing arts;

Medical research;

The relief of disability or severe illness;

The accommodation of those in need.

The application must relate to the financial impact of COVID-19, starting no earlier than 1 March 2020;

Applications will not be accepted from 'Friend's-Of' charities;

The applicant's beneficiaries must be primarily in the UK.

What can the funds be used for:

Staff costs and other overheads (except where staff are not required and/or staff could have been furloughed) where income has been affected by COVID-19 or the lockdown;

Increased demand for services linked directly to COVID-19 or the lockdown;

Changes to working practices, such as the purchase of laptops or remote access technology, protective equipment to work safely with beneficiaries;

Deep cleaning of premises because of a confirmed case of COVID-19.

### **The Volant Trust: COVID-19 Response Fund**

The Volant Trust accepts applications from registered charities, community interest companies, community organisations and social enterprises in the UK and internationally that demonstrate a strong focus on alleviating social deprivation and helping vulnerable groups who have been particularly impacted by the Covid-19 pandemic.

Funding is available for project and administrative costs although applications for medical equipment and the production or distribution of PPE will also be considered.

\* To receive a decision by April 2022 applications must be submitted between 1st August and 31st December 2021

### AllChurches Trust Ltd

AllChurches Trust Ltd supports projects run by churches of many denominations and Christian organisations. Their primary charitable objective is to promote the Christian faith or any other charitable purpose.

The Trust focuses on building communities, helping people to flourish, and growing churches.

Their grants normally fund capital projects and equipment and not salaries or running costs. They only fund projects in the UK and Ireland. They give grants to churches of many denominations, so long as they are members of Churches Together in England (CTE), Action of Churches Together in Scotland (ACTS), Churches Together in Wales (Cytun), the Irish Council of Churches or a local 'churches together' group. All applicants, including education establishments, need to be a UK registered charity, church or have "exempt" status.

### The Alliance Family Foundation

Grants for UK registered charities for a wide range of charitable causes, with a preference for projects that focus on education, the relief of poverty and religious activities in England, Wales, Israel and the USA.

Their grants are available to any Christian place of worship in the UK that is open for regular worship. From repairing a roof to helping to install an accessible toilet - and many other projects - their grants help keep churches open for worship and community activities and allow them to continue to serve people and communities in all sorts of ways.

The National Churches Trust offer 4 types of grant:

- Cornerstone: For urgent and essential structural repair projects with estimated costs of at least £100,000 that will help places of worship become wind and watertight, and for installing kitchens and toilets with estimated costs of at least £30,000, to improve access for all.
- Gateway: To support churches in their project development up to RIBA stage 1; supporting local church trusts; and essential repair projects with estimated costs of between £10,000 and £100,000.

- Foundation Grants for Maintenance: Grants to support small, urgent maintenance and repair issues or to carry out small investigative works costing up to £10,000.
- Preventative Maintenance Micro-Grants: Churches can apply for a Preventative Maintenance Micro-Grant if they book a service for work direct to their church building through the MaintenanceBooker website.
